# **NOTES AND SOURCES**

This book is the culmination of a decade of reporting on diet culture and anti-fat bias, including a year writing a monthly column on kids' food and body image for the *New York Times*'s Parenting section, and almost two years (so far) writing my weekly newsletter, *Burnt Toast*, and producing the *Burnt Toast Podcast*. In researching this book, I drew on that body of work, as well as on the conversations I've had with readers in my newsletter comment section, or via email and Instagram DM. I also interviewed over one hundred parents, kids, researchers, doctors, scientists, dietitians, and advocates specifically for this project. And I read and analyzed hundreds of studies, articles, books, blogs, and social media posts and listened to many podcasts. All the published materials that provided the quotes, statistics, and research details referenced throughout the book, or that more generally informed my thinking on these issues, are listed chapter by chapter below.
